The Age of Consent in UAE is 21 lunar years (Article 85 of the UAE Civil Transaction Law) which is the equivalent approximately to 20 years, 4 months, 20 days of the Gregorian Calendar.

When RAK Insurance receives a transaction instruction from you through the payment gateway, we will be entitled to debit the amount of payment plus any charges payable for the transaction from the account/debit or credit card you have specified.
